Ideally we'd like to receive maps, photos and/or videos of premises before and after Cyclone Gabrielle and before and after the sediment and debris recovery work has been undertaken. This will hep us judge the scale and need for the work that is being applied for.
6.4	Please provide any reports or independent or expert advice on the required scope of the Eligible Works	If you have this evidence it will make it easier to assess the application. We understand that a lot of people won't have reports like this, and it would be an additional cost to procure an independent report. This is ok, but it will be important for you to be as detailed as possible on the work that needs to be undertaken and the itemised cost of that work.
6.5	Please provide invoices or supporting evidence for direct costs if the Eligible Works have already been undertaken.	Ideally we would like to see invoices for work that has been undertaken by 3 rd parties.
6.6	If the Eligible Work includes 'in-kind' expenditure, please provide supporting evidence of how expenditure has been calculated (such as quantity surveyor report on hours required to remediate land)	If you have done the work, or intend to do the work, yourself we ideally need you to itemise out the work along with actual or estimated (person and/or machine) hours. We have provided some guidance on hourly rates and machine rates in the application form. If you have timesheets for yourself or your employees doing the work, it will help with the assessment, too.
6.7	If the expenditure relating to the Eligible Work is being requested in advance, please provide quotes or supporting evidence for direct costs	Ideally we would like to see quotes for work that will be undertaken before 30 June 2024. We understand that it is not always easy or quick to receive quotes or estimates. In a situation where it is not possible to provide quotes from 3 rd parties we will be looking for the work and estimated costs to be itemised and related to the map, photos/videos and any other evidence you have provided. We have provided some guidance on hourly rates and machine rates in the application form. If some work has already been undertaken we will look to compare these costs to estimated future costs.

In cases where the applicants have already undertaken all or most the work through 3 rd parties and seeks funding to recover those costs, providing invoices (which have been paid for) can serve as sufficient evidence of co-funding. In instances where the work is substantially yet to be undertaken, it is important we have evidence that you have the funds, or can access the funds, to undertake the work. We will not be able to progress your application without this evidence. Ideally we would want to see proof that you have funds in an account or a letter of support from a bank, shareholder, or similar.
